- About the treatment of personal information. I decide to enter my personal data having been duly informed about the following:

· I acknowledge that the term of the project is scheduled until July 18, 2023, therefore I must create business strategies that allow me to bring new members, give continuity or cause loyalty in each of the members, taking into account that the project map is designed to complete 250,000 memberships.

· EMPORIO GLOBAL within its operational management is empowered to create and / or launch different strategies aimed at growth and expansion, such as travel, incentives, offers, new packages and promotions, while rewarding and generating a lifestyle according to the work and developed leadership of its associates.

Submissions must be made strictly in accordance with the following format, otherwise my affiliate code will be blocked and / or canceled, if I do not do so:

- Every time a membership is purchased, whatever the value, 8% administration must be paid one time, included in the value of the membership. Under no conditions, the company will refund paid memberships after they have been registered.



## **FOUNDERS OF GLOBAL EMPORIO AND NEW GENERATION:**

In our database there are two types of members:

### **1. FOUNDERS:**

Refers to all memberships entered from March 16, 2018 to July 18, 2020. These memberships will be entitled to a refund of the value of their membership, at the end of the project, or when they wish to withdraw from the company, only if you are in Manual renewal.

### **2. NEW GENERATION:**

On July 18, 2020, the closing of a generational cycle of EMPORIO GLOBAL took place, and the birth of a spectacular cycle for a privileged global community, which are our first promotion.

The second generation starts from July 19, 2020 until the company closes in July 2023, this generation will be identified as: NEW GENERATION.

These memberships will not be entitled to a refund of the value of their membership, at any time.

## **COMPENSATION PLAN**

### **1. PASSIVE INCOME BONUS.**

The main product of the project is represented in this bond, which is the profitability or profits obtained through the purchase of one of the eight (8) memberships that the company offers:

The first decision that must be made according to the credibility and trust in the company is to determine which membership to acquire, after choosing the membership, and registering and making the payment, the system automatically generates the option within your new membership to choose the modes of time and percentage in which you want to obtain the payment of profitability. Once the mode is chosen, the membership will be activated to start enjoying the benefits that EMPORIO GLOBAL offers.

### **MODES:**

#### **AMATEUR:**

- Its main feature is that the earnings can be withdrawn monthly. Earnings are generated faster, but the rent is lower than the other modes (PRO AND MASTER).
- The value of the membership is fixed term for three months.



- Membership profitability can be withdrawn every thirty (30) days. There are three (3) withdrawal requests: At thirty (30) days, at sixty (60) days, and at ninety (90) days.

### **PRO:**

Its main characteristic is that the profits can be withdrawn after ninety (90) days and the payment percentage is higher than in the AMATEUR bonus. · In PRO mode, the capital remains static for ninety (90) days, just like profitability. The person who purchases any membership and chooses the PRO mode, is agreeing to receive the payment of the total accumulated during the ninety (90) days.

### **MASTER:**

Anyone who purchases one of the eight (8) memberships will have the possibility to choose whether to put it in MASTER mode. The MASTER mode, its main characteristic is that the capital and earnings are only received in the sixth month or one hundred and eighty (180) days after the purchase of the membership.

### **FOUNDERS:**

Memberships **FOUNDERS**, who have not received the total value of their membership in passive bond, will continue to receive the percentage as follows:

**Amateur mode:** 10%

• **Pro mode:** 42%

**Master mode:** 108%

At the time of receiving 100% of the return of the value of your membership in a passive bond, the system will readjust said bond, to continue enjoying the benefits as follows, which will be called:

## 2. SPONSOR BONUS.

This bonus is paid only once as a result of the sale of a membership. · The Sales Bonus is ten (10%) percent of the value of the membership sold without interest in the value of the sponsor's membership.

### 3. BINARY BONUS.

The Binary Bonus is paid as a result of the growth of each leader's network taking its two downlines.

The percentage is 10% paid for the short line for all active users who have not reached ranges and similarly for ranges from JADE to RUBI.

For subsequent ranges, it will be paid with the following percentages:

- ESMERALDAS: 7% for its short line.
  - DIAMONDS: 6% for its short line.
  - DOUBLE DIAMONDS FORWARD: 5% for its short line.
- Take the points of each membership below your position and generate payments on the percentage depending on the rank. This will be settled from the shortest line. The settlement of the points will be: 1 point equals 2 dollars. As described in the following table:

- All the memberships that continue to arrive, structuring the network, whether they are direct members or third parties, generate points, without the need for the binary to be active.
- To Activate and Collect the Binary you must have two (2) direct minimum, one (1) on each line. In the binary score, the membership points that the ascending line places below its position are added.
- In this binary structure the points are unlimited or infinite.

\* WEEKLY WITHDRAWAL IN BINARY BONUS:

This bonus has a weekly withdrawal limit, according to the membership in which you are. Below are the memberships and their weekly limits:

### 3. CAREER PLAN BONUSES:

The career plan is a way to achieve ranks through the growth of your teams, the meter will be made by advancing ranks on the shortest line and the points reached on that line.

Upon reaching the ranges JADE, PEARL, SAPPHIRE, RUBY, EMERALD and DIAMOND, DOUBLE DIAMOND, TRIPLE DIAMOND, AMBASSADOR DIAMOND and CROWN DIAMOND, the bonuses are generated in USD, and the high ranks will have an additional high impact benefit for those who achieve them.



To qualify for ranks, the following requirements must be taken into account: · As you move up in rank, you must go up in membership as indicated in the following table:

It must have a volume of points for the shortest line, this score is added daily by the growth of their teams and they can be accumulated for the ranges, month by month. · As the person rises from the rank, he must appear from permanently the rank in the virtual office with the distinctive and name of the rank in which it is located.

· The rank is never lost · The ranks are reached as long as the requirements are met, not interested that it does not do so at the end of the month · To reach the ranks, the leader must train other leaders. Each rank has leadership requirements that are: accumulate points for the shortest line, specific membership and leadership requirement, stipulated in the table above.

## 5. CYCLE EXPANSION BONUS

This bonus is designed to share or celebrate the growth of the EMPORIO GLOBAL company with a draw each time a bar and / or growth cycle is reached. There are 8 bars with a certain number of memberships sold.

Each bar once the previous one is filled, will start with zeros, that is, the two thousand (2,000) memberships of the first cycle do not add up to the second cycle, since only in this way would we add the two hundred and fifty thousand (250,000) memberships.

The Expansion by Cycles bonus, is comprised of 8 cycles with prize pools, below we detail the number of memberships that must be registered in each cycle:

For each bar that is filled, a raffle is generated, in each raffle all members of the EMPORIO GLOBAL family participate without any requirement, only to be part of our community.

When the bar is full, any member can be one of the winners in the prize draw.

The profits generated during the entire project will be "Private Company Information".

## **6. MEMBERSHIP RENEWAL:**

The renewal periods are every three months for memberships in AMATEUR and PRO mode, while for memberships in MASTER mode the renewal is every 6 months.

There are two types of renewal:

When entering the company, there will be two ways to choose your renewal:

- **AUTOMATIC RENEWAL:**

This type of renewal is chosen at the time of registering your membership, it is characterized by making you participate in the



passive bond until the end of the project in the year 2023. Before this time, you will not be able to withdraw the value of your membership.

- **MANUAL RENEWAL:**

When the person buys a membership and chooses the mode (AMATEUR, PRO OR MASTER) but does not select automatic renewal for any particular reason, the following should be taken into account:

- The option to manually renew will always be available to the associate (During the three (3) months in the case of AMATEUR and PRO or six (6) months in the case of the MASTER). That is, the associate can change the option to renew his membership at the time he wishes to do so, while it is active.
- If the associate did not activate this option in the registration of affiliation or during the time of their membership, but wishes to continue in EMPORIO GLOBAL, they have a period of twelve (12) calendar days to activate it from the day the time ended ( the way you chose when you first registered), or conversely to withdraw your capital. If during these 12 days you did not renew your membership, the system will automatically renew it.
- The associate must know that once the membership is inactive, (during these 12 days) he will stop receiving all residual and passive commissions. Neither will it be able to generate retroactivity (after the renewal) of the points or commissions generated during the days that it remained inactive.

## **7. UP GRADE:**

Each person who owns a membership is free to do the up grade at the time they want. When doing the up grade, you must pay the differential value between the membership you have and the one you want to buy, likewise, you must pay the administration difference between the two memberships.



· When someone does Up grade, it generates on the differential that paid points in the binary tree. When membership is first purchased: One dollar equals half a point; but when it is done up grade (the value of dollars per point increases): 4 dollars equals one (1) point. These points are automatically reflected in the software for the entire upline of the binary tree.

Example of points settlement for an upgrade: If a membership is Basic (\$ 250) and upgrades to Entrepreneur (\$ 2,500), the value differential is 2,250, the number of points generated by this upgrade for all its upline is 562.5 .

When any membership performs Up grade (can be done at any time) and pays the differential, the countdown of the days corresponding to the mode in which it is is automatically restarted. That is to say, a membership was on its forty day of the ninety (90) days and had already received its payment of the first month, but on the forty (40) day it upgrades, it immediately restarts the ninety (90) days again; since it is a new membership that begins for the person. The ten calendar days of the second month will be prorated and paid at the same time.

· When a person upgrades their membership, they do not generate a quick start bonus for their sponsor.

· If a FOUNDER membership performs an Upgrade before July 19, 2020, and it has already received in its liabilities, the return of the value of its membership, this membership with its Upgrade, will continue to receive the percentage of liabilities from the FOUNDERS. These apply to return the value of the membership, at the end of the project, or at the same time you want to withdraw from the company, if you are in Manual Renewal.

· If a FOUNDER membership performs Upgrade after July 19, 2020, the system will reflect two passive bonus payments, where the first will be the initial value, which will continue with the



percentage it brought, to which it will be updated the new percentage, once you reach the value of the return of your membership. This value will be entitled to return of the Capital at the end of the project in 2023, or when you want to withdraw from the company, only if you are in Manual Renewal.

The value of the Upgrade made after July 19/2020, will be the second passive bonus that the system will reflect, this will be with the percentage of the NEW GENERATION. This value does not apply to return the value of the membership, at any time.

## **8. MODE CHANGES:**

Anyone who has purchased a membership can change the mode at the time of renewal (as long as it is to increase the time in the company and not vice versa), that is, to pass it from AMATEUR to PRO; AMATEUR to MASTER or PRO to MASTER.

- If a FOUNDER membership changes mode after July 19, 2020, said membership will remain FOUNDER.
- If a FOUNDER membership, changes mode after July 19, 2020, and has not yet received the return of the value of the membership in its liabilities, it will continue with the percentage of THE NEW GENERATION, and at the time of receiving 100 % of the value of its membership, the percentage drops to that of the FOUNDERS. This will be entitled to the return of the value of your membership at the end of the project, or failing that, when you want to withdraw from the company, only if you are in Manual Renewal.

## **9. RETURN OF THE VALUE OF YOUR MEMBERSHIP:**

- FOUNDERS memberships will be entitled to receive their capital at the end of our project, as has always been promised. If they do not want to continue in the company, they can make their capital



request, at the end of the way they are, as long as their membership is in Manual mode.

- The NEW GENERATION memberships will not be returned to the capital, neither at the time of leaving the company, nor at the end of the project, due to the new payment modality for this new generation of the company.

## **10. WITHDRAWALS:**

- Payments and withdrawals are made through E-Transfer, with this option you can both pay the entry of a new membership, as well as transfer your tokens to another user whom you want. The Payout from the E-Wallet to the E-Transfer, has a discount of 8%.

- The 8% fee will apply for All bonuses, prizes, contests et more payments made by Emporio Global with E-transfer model.
