As an active EMPORIO GLOBAL ASSOCIATE, I understand and agree that:

- I am of legal age in the country where I reside. - I am an independent person, responsible for my decisions and leadership, I develop my business without any control or manipulative agent by Emporio global. - I am responsible for the payment of all taxes involved in self-employment, as well as any other requirements of the law within the country of my residence. - About the treatment of personal information. I choose to enter my personal data having been duly informed about the following:

a. That there will be a database, which will be for internal use and not for commercialization of the information.

b. That the information will be treated confidentially, for internal use (directly or indirectly) by EMPORIO GLOBAL and all that is part of it.

- I do not have any type of employment contract that legally binds me to EMPORIO GLOBAL and this does not represent any kind of employment relationship. - This platform shall only be used for your own benefit and is for the exclusive and personal use of registered members, such members shall not provide access to your account to third parties. The member who provides his/her account and/or access to the same shall be exclusively responsible for the actions performed by these third parties.

- None of the benefits provided by this service will be used for illicit purposes or in connection with funds related to illicit activities. I declare that the money used for the purchase of memberships does not come from such funds. - I will not denigrate the name of the company which provides me with a better quality of life and a guarantee of sustainable earnings.

- Under no justification or purpose will I create, use or duplicate any kind of misleading advertising related to EMPORIO GLOBAL. -



I will not generate confrontations or discussions with people from other organizations denigrating their companies or projects.

- I will assume responsibility for supporting the people I sponsor in the program and in my commissionable downline by maintaining constant and assertive communication through any of these means: personal contact, telephone and/or written communication.

- The ways to purchase a membership are:

1. Purchasing it directly from the company through the cryptocurrency Bitcoin (BTC). Payment will be made through the QR code, which will be at the end after completing the new member registration. For successful activation, it is necessary not to change any data, such as value or wallet address. (The costs of the transfer fee will be borne by the members).
2. By means of the E-Transfer, which works as a means of payment or as a transfer of tokens to the desired users.
3. Or alternatively, it can be a mixed payment, which is enabled to pay the amount you want with E-Transfer and the differential in cryptocurrencies such as Bitcoin (BTC) or Ethereum (Eth).

- The status of any affiliated person is "MEMBER" and I acquire it at the moment I purchase a membership. - In order to maintain a viable business presentation and if within the financial analysis there is a need; EMPORIO GLOBAL reserves the right to partially or totally modify the compensation plan that together with the changes that derive from it, will become a binding part of this document and will be valid once it is disclosed in the authorized site www.emporioglobal.net (Web Page) of EMPORIO GLOBAL.

- I recognize that the project is scheduled to run until March 15, 2026, therefore I must create business strategies that allow me to bring new members, give continuity or cause loyalty in each of the



members, taking into account that the project map is designed to complete 250,000 memberships.

- EMPORIO GLOBAL within its operational management is empowered to create and/or launch different strategies aimed at growth and expansion, such as trips, incentives, offers, new packages and promotions, rewarding and generating at the same time a lifestyle according to the work and leadership developed by its members.

- I will spread the opportunity that EMPORIO GLOBAL offers personally and virtually with the right ethics and prudence. EMPORIO GLOBAL, offers the following Passive and Active Payment Plan. Submissions must be made strictly according to the following format otherwise my affiliate code will be blocked and/or cancelled, if I fail to do so:

- Each time a membership is purchased, regardless of the value, a one-time 8% administration fee must be paid, which is included in the value of the membership. Under no condition, the company will refund paid memberships after they have been registered.



FOUNDERS OF GLOBAL EMPORIUM AND NEW GENERATION:

There are two types of members in our database:

1. FOUNDERS:

Refers to all memberships entered from March 16, 2018 until July 18, 2020. These memberships will be entitled to a refund of the value of your membership, at the end of the project, or when you wish to withdraw from the company, only if you are in Manual renewal.

2. NEW GENERATION:

July 18, 2020, marked the closing of a generational cycle of EMPORIO GLOBAL, and the birth of a spectacular cycle for a privileged global community, which are our first graduating class.

The second generation starts on July 19, 2020 until the closing of the company in March 2026, this generation will be identified as: NEW GENERATION.

Members of this generation will not be entitled to a refund of their membership fee at any time.

COMPENSATION PLAN

1. PASSIVE INCOME BONUS.

This bonus represents the main product of the project, which is the profitability or earnings obtained through the purchase of one of the eight (8) memberships offered by the company:

The first decision to be made according to the credibility and trust in the company is to determine which membership to acquire, after choosing the membership, registering and making the payment, the system automatically generates the option within your new membership to choose the modes of time and percentage in which you wish to obtain the payment of the profitability. Once the requested mode is chosen when entering the new backoffice, the membership will be active to start enjoying the benefits offered by EMPORIO GLOBAL.

MODES:

AMATEUR:

- Its main feature is that profits can be withdrawn monthly. Profits are generated faster, but the income is lower than the other modes.
- The value of the membership is fixed term for three months.



- The profitability of the membership can be withdrawn every thirty (30) days. There are three (3) withdrawal requests: Thirty (30) days, sixty (60) days, and ninety (90) days.
- The percentage is 8% per month.

PRO:

Its main feature is that profits can be withdrawn after ninety (90) days and the payout percentage is higher than in the AMATEUR bonus. - In the PRO mode, the value of the membership remains static for ninety (90) days, as well as the profitability. The person who purchases any membership and chooses the PRO mode is agreeing to receive payment of the full accumulated amount in the next ninety (90) days.

The percentage to be received is 30% quarterly.

MASTER:

Any person who purchases one of the eight (8) memberships, will have the possibility to choose whether to put it in MASTER mode. The main characteristic of the MASTER mode is that the value of the membership and the earnings are only received after the sixth month or one hundred and eighty (180) days after the purchase of the membership. The payment percentage is 70% semi-annually.

SENIOR:

Any person who purchases one of the eight (8) memberships, will have the possibility to choose whether to put it in SENIOR mode. Its main feature is that the capital and profits are only received at the end of the first year or three hundred and sixty (360) days after the purchase of the membership. The payout percentage is 180% per annum.



PREMIUM:

Any person who purchases one of the eight (8) memberships, will have the possibility to choose whether to put it in PREMIUM mode. Its main feature is that the capital and profits are only received at the end of the second year or seven hundred and twenty (720) days after the purchase of the membership. The payment percentage is 400% Biannual.

SUPREME:

Any person who purchases one of the eight (8) memberships, will have the possibility to choose whether to put it in SUPREME mode. Its main characteristic is that the capital and profits are only received at the end of the third year or one thousand eighty (1080) days after the purchase of the membership. 2. QUICK START BONUS.

This bonus is paid on a one-time basis as a result of the sale of any membership. - The sales bonus is ten (10%) percent of the value of the membership sold regardless of the value of the sponsor's membership.

3. BINARY BONUS.

The Binary Bonus is paid out as a result of the growth of each leader's network by taking their two downlines.

The percentage is 5% paid by the short line, settled by the points earned in the week; for all members, regardless of the value of the membership or the rank acquired.

- The settlement of points will be: 1 point equals 2 dollars. As described in the following table:

- To Activate and Collect the Binary you must have a minimum of two (2) direct memberships, one (1) in each line. In the score of the binary the points of memberships that the ascending line places under its position are added.
- In this binary structure the points are unlimited or infinite.



- You should have one direct to the left and one direct to the right of your team.
- You must fulfill 1 referral every 28 days, regardless of the new user's membership value and location in your network; this direct referral will activate for the next 28 days the **binary count and rank points** in your virtual office.

All memberships that enter, structuring the network whether they are direct or third party members will generate points, but these will not be reflected if a direct member has not entered in that month.

When will it be applied? The company will give the first 28 days of grace as of March 15, 2021, which means that this condition will be applied on April 12, 2021.

IMPORTANT

1. It should be clarified that the registration of 2 users within the same 28 days will not add up to the next 56 days, but will **always take into account the date of the last registration to start your 28 days.**
2. When the 28 days expire and the user has not registered any direct referrals, his binary points and ranks will not be accumulated and will be lost.
3. Upgrades do not apply to this condition.
4. NEW USERS AND THEIR APPLICATION: The new users that enter after May 17th and on the date they make their first registration have an accumulated binary spill points, these will not be counted. The points will start to be added in your BackOffice the day you make your first registration and will be added up to 28 days after the date of this registration, if the user does not activate the binary, that is, a direct for each line, this will not be able to collect your points and these will be lost.

4. CAREER PLAN BONUSES:

The career plan is a way to achieve ranks through the growth of your teams, the meter will be made by the advancement of ranks on the shortest line and the points achieved on that line.

Upon reaching the JADE, PEARL, SAPPHIRE, RUBI, EMERALD, DIAMOND, DOUBLE DIAMOND, TRIPLE DIAMOND, AMBASSADOR DIAMOND, PRESIDENT DIAMOND, CROWN DIAMOND AND ROYAL DIAMOND ranks, bonuses are generated in USD, and high ranks will have an additional high impact benefit for those who achieve them.

To qualify for ranks, the following requirements must be taken into account

:- As you move up in rank, you must move up in membership as indicated in the following chart:

You must have a volume of points for the shortest line, this score is added daily by the growth of their teams and are cumulative for the ranks, month by month. - As the person moves up in rank, the rank must appear permanently in the virtual office with the badge and name of the rank in which he/she is.

- The rank is never lost. - Ranks are achieved as the leader fulfills the requirements, regardless of whether or not he/she does so at the end of the month. - To achieve the ranks, the leader must train other leaders. Each rank has leadership requirements, which are: accumulating points for the shortest line, specific membership and leadership requirement, stipulated in the table above.

To accumulate rank points you must be active with direct every 28 days.



5. CYCLE EXPANSION BONUS

This bonus is designed to share or celebrate the growth of the EMPORIO GLOBAL company with a drawing each time a bar and/or growth cycle is reached. There are 8 bars with a set number of memberships sold.

Each bar, once the previous one is filled, will start from zero, that is to say, the two thousand (2,000) memberships of the first cycle do not add up to the second cycle, since only in this way would we add up the two hundred and fifty thousand (250,000) memberships.

The bonus Expansion by Cycles, is comprised of 8 cycles with prize pools, as follows we detail the number of memberships that must be enrolled in each cycle:

For each bar that is filled a drawing is generated, in each drawing all members of the EMPORIO GLOBAL family participate without any requirement, only that they are part of our community. When the bar is filled, any member can be one of the winners in the prize drawing.



Earnings generated throughout the project will be "Company Proprietary Information".

6. MEMBERSHIP RENEWAL:

Renewal periods are every three months for memberships in mode: AMATEUR and PRO, for memberships in MASTER mode the renewal is every 6 months. SENIOR mode memberships renew every year, PREMIUM mode memberships can renew every 2 years, and for SUPREME mode memberships, renewal is every 3 years.

There are two types of renovation:

Upon joining the company, there will be two ways to choose your renewal:

- **AUTOMATIC RENEWAL:**

This type of renewal is chosen at the time of registration of your membership, it is characterized by making you a participant of the passive bonus until the end of the project in 2023. Before this time, you will not be able to withdraw the value of your membership (only if you are a founder).

- **MANUAL RENEWAL:**

When the person purchases a membership and chooses the mode (AMATEUR, PRO or MASTER) but does not select automatic renewal for any particular reason, the following should be taken into account:

- The option to renew manually will always be available to the associate (During the three (3) months in the case of AMATEUR and PRO, six (6) months in the case of MASTER, SENIOR mode memberships can be renewed every year, PREMIUM mode memberships can be renewed every 2 years, and for SUPREME mode memberships, the renewal is every 3 years.). That is to say,

the associate can change the option to renew his membership whenever he wishes to do so, as long as it is active.

- If the associate did not activate this option in the affiliation registration or during the time of his membership, but wishes to continue in EMPORIO GLOBAL, he has a period of twelve (12) calendar days to activate it from the day in which the time ended (the way he chose when he registered for the first time), or on the contrary to withdraw his capital (only if he is a Founder) If in the course of these 12 days he did not renew his membership, the system will automatically renew it.

- The associate must know that once the membership becomes inactive, (during these 12 days) he/she will no longer receive all residual and passive commissions. You will not be able to generate retroactivity (after the renewal) of the points or commissions generated during the days of inactivity.

7. UP GRADE:

Each person who owns a membership is free to upgrade at any time he/she wishes. When upgrading, he/she must pay the differential value between the membership he/she has and the one he/she wishes to purchase, as well as the difference in the administration fee between the two memberships.

- When someone makes Up grade, he/she generates on the differential that paid points in the binary tree. When the membership is purchased for the first time: One dollar equals half a point; but when it is upgraded (the dollar value per point increases): 4 dollars equals one (1) point. These points are automatically reflected in the software of the entire upline of the binary tree.

Example of points settlement for an upgrade: If a member is on Basic (\$250) and upgrades to Business (\$2,500), the value differential is 2,250, the amount of points that this upgrade generates for his entire upline is 562.5.



When a membership upgrades (it can be done at any time) and pays the differential, the countdown of the days corresponding to the mode in which it is in is automatically restarted. That is to say, a membership was on its fortieth day of the ninety (90) days and had already received its payment for the first month, but on the fortieth (40th) day it upgrades, immediately the ninety (90) days are restarted again; since it is a new membership that starts for the person. The ten days of the second month will be prorated and will be paid at the same time.

- When a person upgrades their membership, they do not generate a fast start bonus to their sponsor.

8. MODE CHANGES:

Any person who has purchased a membership, can change the mode at the time of renewal (as long as it is to increase the time in the company and not the other way around), i.e. from AMATEUR to PRO; AMATEUR to MASTER, PRO to MASTER, AMATEUR TO PREMIUM, and so on as long as it is ascending.

9. REFUND OF THE VALUE OF YOUR MEMBERSHIP:

- FOUNDER memberships, will be entitled to receive the full value of their membership at the end of our project, as always promised. In case they do not wish to continue in the company, they can make their capital request, at the end of the mode they are in, as long as their membership is in Manual Renewal.
- The NEW GENERATION memberships will not be refunded the total value of their membership at the time of withdrawal from the company, nor at the end of the project, due to the new payment method for this new generation of the company.



10. WITHDRAWALS:

- Payments and withdrawals are made through the E-Transfer, with this option you can either pay for a new membership or transfer your tokens to any other user you wish. Payout from the E-Wallet to the E-Transfer has an 8% discount.
- All bonuses, prizes, contests and other payments made by the company will be discounted by 8%, with payment mode in deposit to the E-Transfer.

11. MAXIMUM WEEKLY WITHDRAWAL:

The maximum value per weekly withdrawal is \$25,000.

The company's growth must be as it has always been: responsible and sustainable over time.
